In Islamic jurisprudence, qiyas ( Arabic: قِيَاس ) is the process of deductive analogy in which the teachings of the hadith are compared and contrasted with those of the Qur'an, in order to apply a known injunction ( nass) to a new circumstance and create a new injunction. Here the ruling of the Sunnah and the Qur'an may be used as a means to solve or provide a response to a new problem that may arise.
